BACKGROUND

Joined the Royal Malaysian Police in 1965 and retired after 33 years of service in 1998 with the rank of Assistant Commissioner of Police. Has 19 years experience in the Special Branch which covers a wide range of Police trade craft which includes procurement of tactical intelligence, overt and covert handling of undercover operations with surveillance, Counter insurgency operations, and International Counter Espionage.

He has another 14 years of experience within the Criminal Investigation Department (CID), Internal Affairs Department and service as the Officer in Charge of Klang Police District (OCPD), which covers Investigations into crime, internal affairs, Narcotics and Command Management etc. He was also specially trained in Special Weapons and Tactics (SWAT) to combat urban terrorism by armed mobile communist units during communist insurgency.
